Petitions for Nomination - Independent Municipal Candidate: {A.C.A. §14-42-206(b)(1)}

Circulation: **May 9, 2024** - Petitions may begin circulation 90 days prior to filing deadline.

Filing Time: **Begins** – NOON July 31, 2024 **Ends** – NOON August 7, 2024

Any qualified person desiring to be a candidate for municipal office in the General Election to be held on November 5, 2024 must file a Nominating Petition, Affidavit of Eligibility, Petition Affidavit, and Political Practice Pledge with the County Clerk by the deadline date: **August 7, 2024 at 12:00 noon.**

Political Practices Pledge, Affidavit of Eligibility, Petition Affidavit, Statement of Financial Interest and Campaign Contribution and Expenditure forms will be provided to the Candidate at the time of filing. Therefore, it is suggested that the candidate appear, in person, in the office of the County Clerk to complete filing requirements.

For a **City of the First Class**, the Petition must contain signatures from not less than thirty (**30**) qualified electors of the city in which the candidate files.

For a **City of the Second Class or Incorporated Town**, the Petition must contain signatures from not less than ten (**10**) qualified electors of the city in which the candidate files.

NO WRITE-IN CANDIDATES FOR MUNICIPAL OFFICE ALLOWED (A.C.A §14-43-202)

In order to assist the candidate in their filing requirements, information packets and forms are available at the County Clerk's Office. The County Clerk recommends that candidates circulate Petitions for signatures well in advance of the deadline to file in order that proper certification of the signatures on the Petitions may be made.

Deadline to register to vote for the General Election is October 7, 2024.

Early voting for the General Election is Monday, October 21st through Saturday, November 2nd, Weekdays 8:00 a.m. to 6:00 p.m., Saturdays 10:00 a.m. to 4:00 p.m., and Monday, November 4th 8:00 a.m. to **5:00 p.m.**

Statement of Financial Interest: {A.C.A §21-8-701(c)(1)(A)}

A candidate for municipal office must file a Statement of Financial Interest with the **City Clerk or Recorder** by **August 12, 2024**, unless a statement was filed as an incumbent office holder by January 31, 2024, then they shall not be required to file an additional statement.

Campaign Contribution and Expenditure reports: {A.C.A §7-6-208(a)(1)&(2)}

Pre-election Report: {A.C.A. § 7-6-208 (a)(1)}

Candidates are required to file if they receive or spend in excess of five hundred dollars (\$500.00). This Report covers all campaign activity through October 22, 2022.

Deadline to File: October 29, 2024 (No later than seven days prior to the General Election)

Final Report: {A.C.A. § 7-6-208 (a)(2)}

Required of **ALL** candidates, opposed or unopposed, regardless of contributions or expenditures.

Deadline to File: December 30, 2024.
