

2024 NWACC CANDIDATE FILING INFORMATION

A.C.A. §6-61-520

PREPARED BY BENTON COUNTY CLERK'S OFFICE

Any person desiring to be a candidate for a position on the Northwest Arkansas Community College Board of Trustees will:

- File a notarized Statement of Candidacy
- File a Petition containing the signatures of at least twenty-five (25) qualified electors of the zone requesting that the name of such person be placed on the ballot as a candidate for the position on the board.
- Run by zone
- Be elected on a nonpartisan basis
- Must be a resident of the zone within the respective School District.

FILING BY PETITION:

- **May 9, 2024** is the first day for candidates filing by petition to circulate petitions for the General Election being held November 5, 2024. Clerk shall not count as valid any signature dated more than ninety (90) days before the filing deadline (August 7, 2024). A Candidate must **FILE** the Political Practices Pledge, and the Petition during the one-week period beginning July 31, 2024 @12:00 p.m. and ending August 7, 2024 @12:00 p.m.

DRAWING FOR BALLOT ORDER A.C.A. §6-14-111(j):

- Deadline for public meeting of County Board of Election Commissioners to determine by lot the order in which names will appear on the ballot is seventy-two (72) days before the election:
 - Friday, August 23, 2024 @ 1:00pm
