

2024 BEAVER WATER DISTRICT CANDIDATE FILING INFORMATION
GENERAL ELECTION (11/5/2024)
A.C.A. §14-116-303

Any person desiring to be a candidate for a position on the Beaver Water District's Board of Directors must:

- Be a qualified voter
- Be a resident in the service area of the customers of the district, which is the area within the boundaries of the water district to which the customers of the district currently provide retail water or other services that they have purchased from the district.
- File a petition containing at least fifty (50) signatures of qualified registered voters, who shall consist of those electors residing in all or part of any precinct in the service area of the customers of the district from which the director is to be elected
- Complete and file a Political Practices Pledge, in person at the County Clerk's Office

FILING BY PETITION:

- **May 9, 2024** is the first day for candidates filing by petition to circulate petitions for the General Election being held November 5, 2024. Clerk shall not count as valid any signature dated more than ninety (90) days before the filing deadline (August 7, 2024). A Candidate must **FILE** the Political Practices Pledge, and the Petition during the one-week period beginning July 31, 2024 @12:00 p.m. and ending August 7, 2024 @12:00 p.m.

Deadline for public meeting of County Board of Election Commissioners to determine by lot the order in which names will appear on the ballot is not less than seventy-two (72) days before the election:

Friday, August 23, 2024 @1:00pm.

CANDIDATES AT THE TIME OF FILING WILL:

- Receive a condensed version of the General Election calendar
- Receive a Notice of Ballot Draw - A.C.A. §7-5-207(c)
- Receive a Notice of Deadlines to file reporting forms:
 - Receive two Campaign Contribution and Expenditure Forms - Pre-Election Report (if needed); and Final Report (**required**)
- Receive a Statement of Financial Interest – due on the first Monday following the close of the filing period, if one was not previously filed by January 31, 2024.

Deadline to register to vote for the General Election is Monday, October 7, 2024.

Early voting for the General Election is Monday, October 21st through Saturday November 2nd weekdays 8:00 a.m. to 6:00 p.m., Saturdays 10:00 a.m. to 4:00 p.m., and Monday, November 4th 8:00 a.m. – **5:00 p.m.**
